



2024 SEPTEMBER GRAND FINAL COMPETITION

Promotion Rules, Terms & Conditions

Who is running the competition?

The Promoter is Loadex Hire SA Pty Ltd (ABN 57 210 795 266) of 19-21 Opala Street Regency Park SA 5010 (Promoter)

Where will the competition run?

The competition will run online (social media and loadex.com.au) and in store at Loadex Hire SA.

When will the competition start and end?

The competition period starts at 12.01am (ACST) on 18/07/2024 and ends at 11.59pm (ACST) on 30/07/2024 (the Competition Period).

Who can enter?

Entry is only open to Australian residents who are aged 18 years or over, who are current Loadex Hire SA customers. This prize is non-transferable and who can take the major prize on dates is to be determined by the Promoter to coincide with the 2024 Grand Final in Melbourne, Victoria (27/09/2024 to 29/09/2024).

Competition includes:

- One (1x) MCG Category 1 ticket to the AFL Grand Final (28/09/2024)
- Accommodation for a maximum of 2 people for 2 nights in a Deluxe Guest room with King bed, city view and full buffet breakfast for 2 (27/09/2024 to 29/09/2024)
- Welcome event 4pm till 6pm (location will be advised to the winner prior to the experience commencing) (27/09/2024)
- An exclusive money can't buy experience hospitality, pre and post-match

Excluded from entering:

- (a) management, employees, directors and contractors of the Promoter, its related bodies corporate, the participating Stores and other agencies, firms or companies associated with the competition (including suppliers of prizes);
- (b) a spouse, de-facto spouse, parent, guardian, child or sibling of a person referred to in paragraph (a) above;

Do I need to buy anything to enter?

Yes. During the Competition Period, you need to hire any piece of equipment from Loadex Hire SA. Each hire item gives you an entry into the draw.



Entry instructions

After you have made a Qualifying Hire (purchase) you will automatically be placed into the draw.

Every additional hire during the promotional period will give you an additional entry.

No entries will be accepted outside the Competition Period.

When will the winner/winners be chosen?

The winner will be drawn on 02/09/2024 at 19-21 Opala Street Regency Park SA 5010.

The first valid entry drawn randomly from the entries received during the Competition Period will win the major prize.

The Promoter may arrange to draw additional reserve entries in the draw and record them in order, in case a winning entry/entrant is deemed invalid, or a prize is unclaimed (Reserve Entrants).

The winner must be a Loadex Client/and or a pre-approved by the promotor (Loadex Hire SA) suitable replacement.

How and when will the winner be informed?

If you are a winner, you will be informed in writing and by phone within two business days of determination.

If I win, when must I claim my prize?

Unclaimed prize/s

General
